SMART Goal:

Alliance Charter Academy will decrease their overall out-of-school suspension rate by 10% year over year from 2021-2023 by providing classroom teachers with social emotional supports from the PBIS program as well as the school Social Worker, Achievement and Behavioral Support Specialist, Communities in Schools Liaison, etc.

Root Cause(s):

Underlying social / emotional and mental health needs are the root cause to the majority of our severe behaviors that lead to suspension. Increasing the in house social / emotional supports with licensed staff members to support this need. We need to continue to decrease the number of suspensions k-2. Additional positive supports and engagement will support this need.

Student Measure:

All out-of-school suspension rates will decrease 10% year over year with a focus on increased positive behavior entries and a decrease in negative behavior entries.

Adult Implementation Measure:

Alliance Charter Academy will have weekly O3s, as needed mentoring and PD sessions for staff, and will analyze and review all behavioral entries to ensure consistent documentation.

Cost will include supplemental supplies, materials, educational incentives, workbooks, and technology will be utilized to enhance the learning process.
