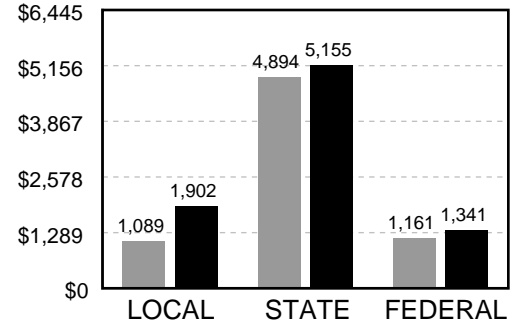

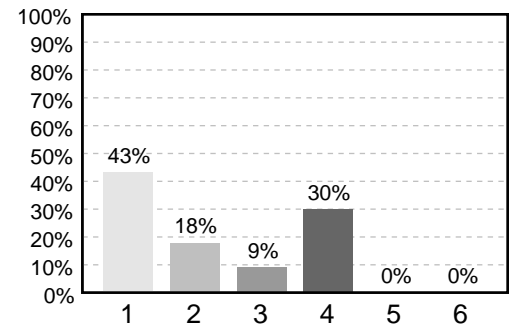

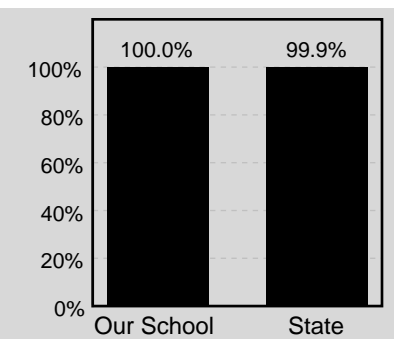

**Adequate Yearly Progress (AYP) Results**

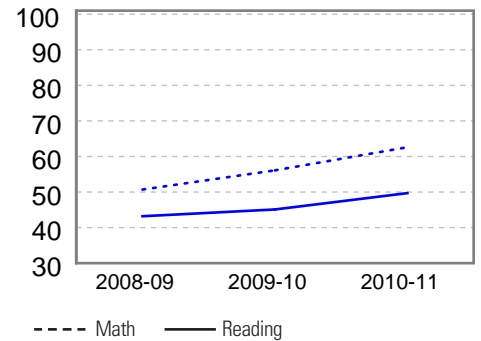
North Carolina has set target goals that schools must meet to make Adequate Yearly Progress (AYP) under the federal No Child Left Behind act.
