For the 2016-17 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

The School Improvement Team's evaluation of data, as part of its continuous school improvement process, revealed key focus areas for improvement. Identified through the process were specific student performance targets in language arts, mathematics, science and social studies. Vanguard desires to increase growth and proficiency in these areas.

The school is taking the following steps to accelerate student achievement:

1. Continue to analyze demographic, perception, student achievement, program and process data to identify areas of need.
2. Differentiate instruction for all students.
3. Provide focused teacher professional develop in EL strategies and instructional alignment between the Common Core State Standards and how the standards are assessed.

4. Provide additional instructional support for students at-risk of not meeting challenging state standards through small group or one-on-one instruction and extended learning time beyond regular school hours, including after school tutoring.
 5. Provide additional instructional support for students at-risk of not meeting challenging State standards through providing high quality, on-going professional development for teachers and support staff.
 6. Student achievement data, including state test data, NWEA data, and local and formative assessment data (including subgroup analysis) is analyzed and discussed by the Leadership Team or a designated School Improvement Team. Results of the analysis determine the school's focus areas and are shared and confirmed by the following stakeholders: 1) Staff, 2) Parents, and 3) Board members.
 7. We have determined that an increased focus on differentiation of instruction will improve overall student performance, particularly through meeting more directly the needs of the school's at risk students. Teachers will work with support staff in the development of targeted intervention for at risk students, and this intervention will be offered both during the regular school day (during workshop time) as well as after school. Additionally, increased differentiation and academic enrichment opportunities will be provided for higher-level learners as well. Based on this data, intervention is needed in focus areas of both reading and mathematics, for all grade levels.
 8. Parents, caretakers and family are a critical part of a child's learning and academic success. Parents can become involved in the following ways:

By law, the school cannot restrict enrollment based on selection criteria. The school can, however, limit the total number of students who may attend the school. If the number of applications exceeds the number of offered seats, a random selection process will determine who attends the school.

The school's Open Enrollment period begins on the first day of the current school year and ends at 5 p.m. on the last day of business in February of the current school year. During this Open Enrollment period, all applications receive equal consideration regardless of the date submitted. At the close of Open Enrollment, all applications received during the Open Enrollment period will be counted. If applications received are fewer than offered seats in each and every grade level, all applicants will be accepted and will receive a notice of acceptance into their respective grades. If the number of applications received exceeds the number of offered seats in any grade level, a random selection process will take place for all affected grade levels. Names are randomly selected until all offered seats have been filled. Any remaining names are selected to establish waiting list priority. Applications received after the Open Enrollment period will be accepted until the end of the current school year and available seats will be filled.

Once students are Enrolled and remain Enrolled, they will remain eligible to be Re-Enrolled at the school for successive years without having to re-apply. However, they will be requested to complete a re-enrollment form by the end of the Open Enrollment period showing their intent to Re-Enroll for the subsequent school year. All applicants on a waiting list must submit an application for the following school year during the next Open Enrollment period.

The Vanguard School Improvement Team (SIT) continued to review and revise the School Improvement Plan (SIP) throughout 2016-2017. The overall goal is for all students to be proficient in Math and ELA as measure by the M-STEP and the NWEA MAP assessment. The SIT met monthly to analyze instruction, curriculum, procedures, and program design and their effectiveness.

Some of the focus areas include:


1. We provide teachers a common planning time to identify students' strengths and weaknesses, set goals, and develop instructional strategies.
2. A workshop model, or small group time is used in both Math and Reading to better differentiate instruction with smaller groups of students who were identified with similar needs.
3. Workshop teams, consisting of specialists, grade level teachers and support staff, have a structured schedule and implement specific instructional and learning strategies during small group instruction targeting the learning gaps.
4. We utilize AIMS Web to progress monitoring to adjust intervention strategies as necessary to promote growth.
5. We have monthly data meetings to ensure all students in K-3rd are growing in reading fluency and comprehension.
6. Data meetings were implemented in all grade levels to adjust instruction to better meet student needs.
7. We utilize Reading Mastery as tool for reading intervention.
8. Math and Reading tutoring occurred after school for students below grade-level to help close the gap.
9. Grade level assessment analysis and planning days were provided to grade level teachers to analyze and plan for instruction based upon student performance on assessment of common core standards.

Professional Development was provided in EL strategies to better instruct all students in learning key academic vocabulary.

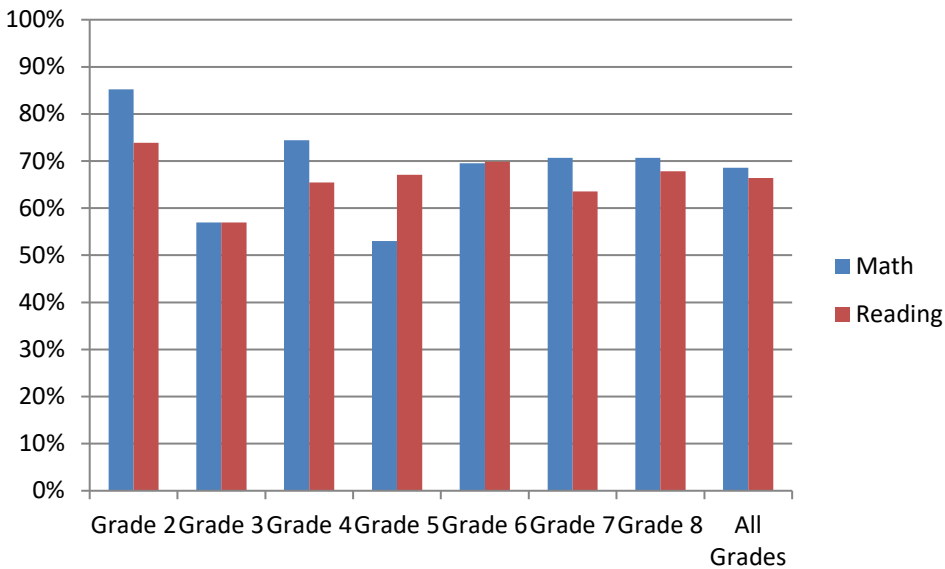

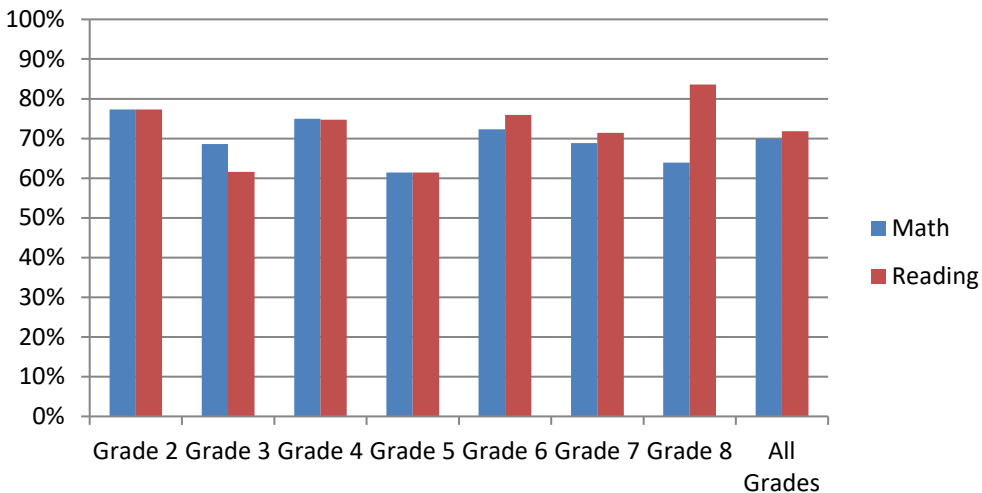

Detailed below is a graph depicting the percentage of students in our school meeting growth targets from fall 2016 to spring 2017.

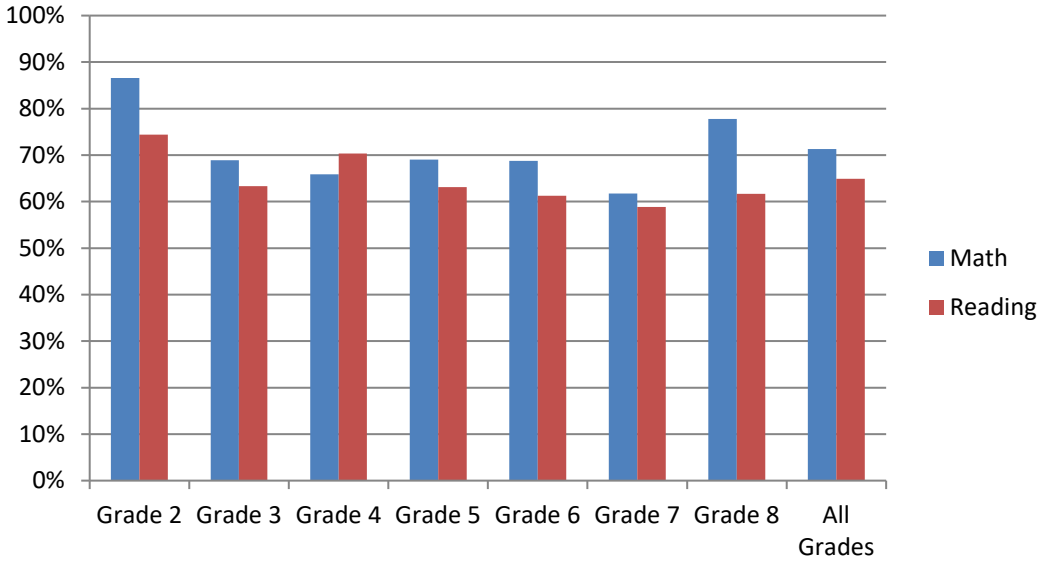


Detailed below are the percentages of students performing at or above the 50th percentile on the spring 2017 administration of the NWEA MAP assessment.

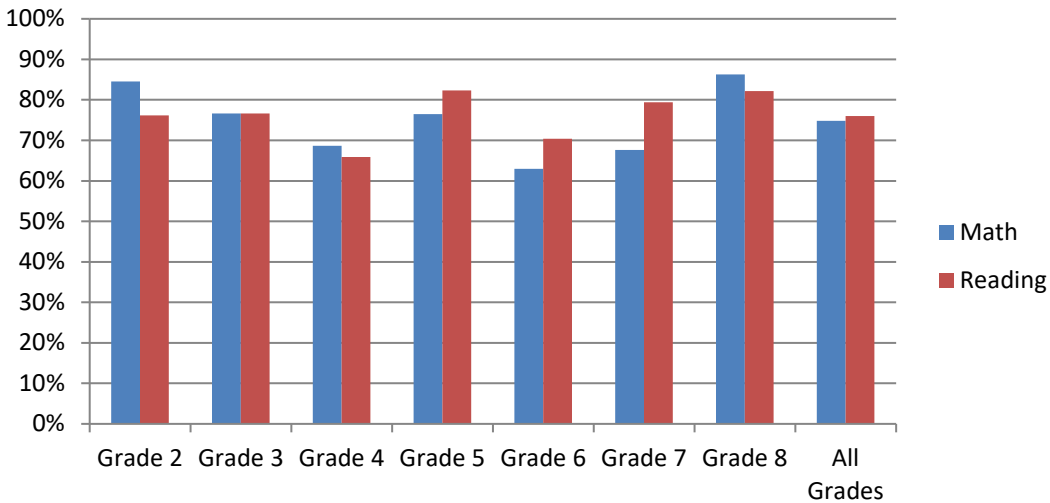

7. SCHOOL YEAR HIGHLIGHTS

- Vanguard increased the Academic Quality Measure increased by 18 percentile points to an overall to 82nd percentile, based upon the 2016-17 M-STEP.
- Vanguard hosts assemblies throughout the year to promote our focus moral virtues through classroom presentations to the student body and also to recognize students who exemplify the moral virtues at school, both inside and outside of the classroom.
