For the 2016-17 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

Based on a review of assessment data, the following goals were selected:

The historical data from Reach shows that our students are not making the proper growth on NWEA and MSTEP. We began to instructionally group our students in order to meet student's specific needs. The students below the 30th percentile have 2 certified teachers in the room in order to give intervention 100% of the day, rather than single a block of time. The core curriculum has been adjusted in those classes, so students can learn at their level. On the flip side, the top students in each grade are in an accelerated class, where they move at a quicker pace, and teachers can add more rigorous content to keep them growing.

Interventions in addition to the instructional grouping to address these goal areas included: adjusted core instruction in math and ELA for our students below the 30th percentile, at-risk teachers and paraprofessional support, and increased high interest books in all classrooms.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

2016-2017

Reach Charter Academy is a state-funded, public school academy. Therefore, there is no cost to attend the Academy. The school is open to any child wishing to attend. Students must be age-appropriate for their respective grade, and they must reside in the state of Michigan.


By law, the school cannot restrict enrollment based on selection criteria. The school can, however, limit the total number of students who may attend the school. If the number of applications exceeds the number of offered seats, a random selection process will determine who attends the school.

The school's Open Enrollment period begins on the first day of the current school year and ends at 5 p.m. on the last day of business in February of the current school year. During this Open Enrollment period, all applications receive equal consideration regardless of the date submitted. At the close of Open Enrollment, all applications received during the Open Enrollment period will be counted. If applications received are fewer than offered seats in each and every grade level, all applicants will be accepted and will receive a notice of acceptance into their respective grades. If the number of applications received exceeds the number of offered seats in any grade level, a random selection process will take place for all affected grade levels. Names are randomly selected until all offered seats have been filled. Any remaining names are selected to establish waiting list priority. Applications received after the Open Enrollment period will be accepted until the end of the current school year and available seats will be filled.

Once students are Enrolled and remain Enrolled, they will remain eligible to be Re-Enrolled at the school for successive years without having to re-apply. However, they will be requested to complete a re-enrollment form by the end of the Open Enrollment period showing their intent to Re-Enroll for the subsequent school year. All applicants on a waiting list must submit an application for the following school year during the next Open Enrollment period.

In an effort to accommodate parents who have more than one child eligible for enrollment, siblings of accepted and currently Enrolled students are given enrollment priority over children who have no such siblings. Siblings of currently Enrolled students at the school will be drawn first in the random selection process, if one is necessary, for offered seats. In addition, if a child is selected during the random selection process, that child's sibling will be offered an available offered seat or the next spot on the waiting list in his/her respective grade. Though siblings are afforded priority for offered seats, they are not given priority over a previously Enrolled student.

In addition to sibling preference, children of staff members employed at the school working a regularly scheduled minimum of 20 hours per week (at least 0.5 FTE) or children of current



board members are given enrollment priority. Though these children are afforded priority for offered seats, they are not given priority over a sibling, or a previously Enrolled student.

All applications received after the Open Enrollment Period will not be eligible to participate in the random selection process, and will be added to the end of the accepted list if offered seats are still available after the random selection process, or to the resulting waiting list created at the time of the random selection process.

In an effort to accommodate parents who have more than one child eligible for enrollment, siblings of accepted and currently Enrolled students are given enrollment priority over children who have no such siblings. Siblings of currently Enrolled students at the school will be drawn first in the random selection process, if one is necessary, for offered seats. In addition, if a child is selected during the random selection process, that child's sibling will be offered an available



offered seat or the next spot on the waiting list in his/her respective grade. Though siblings are afforded priority for offered seats, they are not given priority over a previously Enrolled student.

In addition to sibling preference, children of staff members employed at the school working a regularly scheduled minimum of 20 regularly scheduled hours per week (at least 0.5 FTE) or children of current board members are given enrollment priority. Though these children are afforded priority for offered seats, they are not given priority over a sibling, or a previously Enrolled student.

All applications received after the Open Enrollment Period will not be eligible to participate in the random selection process, and will be added to the end of the accepted list if offered seats are still available after the random selection process, or to the resulting waiting list created at the time of the random selection process.

The school's School Improvement Team reviews data formally and informally throughout each school year as part of its continuous school improvement process. In spring 2017, the school reviewed school and student performance data and perceptual data aligned with the Michigan School Improvement Framework. This review included the following data, among others:

The School Improvement Team's review of data identified priority improvement objectives in the core academic curriculum for the upcoming school year. Reach's overall plan for the 16-17 school year was based on a combination of assessment data. Included are MSTEP results, NWEA MAP testing results, NHA Interim Assessments, and formative assessment results. Thorough this data, it was evident that we need to continue to support our at-risk students effectively with highly qualified teachers and at-risk teachers. In addition, at-risk trends revealed a need for intentional differentiation to core instruction and during workshop.

Strategies at Reach Academy included: data analysis to identify students falling at or below the 30th percentile on state assessments and norm referenced tests. These students are given a differentiated core instruction and have an at-risk teacher (certified teacher) pushed into the classroom at all times. This allows for an entire day of intervention, rather that only a small block of time.

These strategies include instructional grouping of students across all grade levels based on student achievement data. Tiered support systems provided additional instruction for students falling below the proficiency threshold. Intentional instructional planning with formative assessments supported differentiation.


Staff continued to implement the Common Core standards to support college and career readiness. The school improvement team will continue to communicate school-wide goals with all stakeholders, providing opportunities to review, revisit, and revise where necessary.

The SIP has been a road map for our year-long plan. It effectively provides action steps required to meet our school goals. The School Improvement Plan and committees provide an opportunity to have effective dialogue with all stakeholders. This allows for an entire day of intervention, rather than only a small block of time.

These strategies include instructional grouping of students across all grade levels based on student achievement data. Tiered support systems provided additional instruction for students falling below the proficiency threshold. Intentional instructional planning with formative assessments supported differentiation. In addition, after school tutoring and a remote summer program will work to target student's individual needs.

The school serves students from many neighboring school districts. These districts include, but are not limited to: Roseville, East Detroit, Detroit, Warren, Harper Woods, Saint Clair Shores, Grosse Pointe, Frasier and Sterling Heights. In 2016-2017, Reach enrolled 621 scholars from these communities.

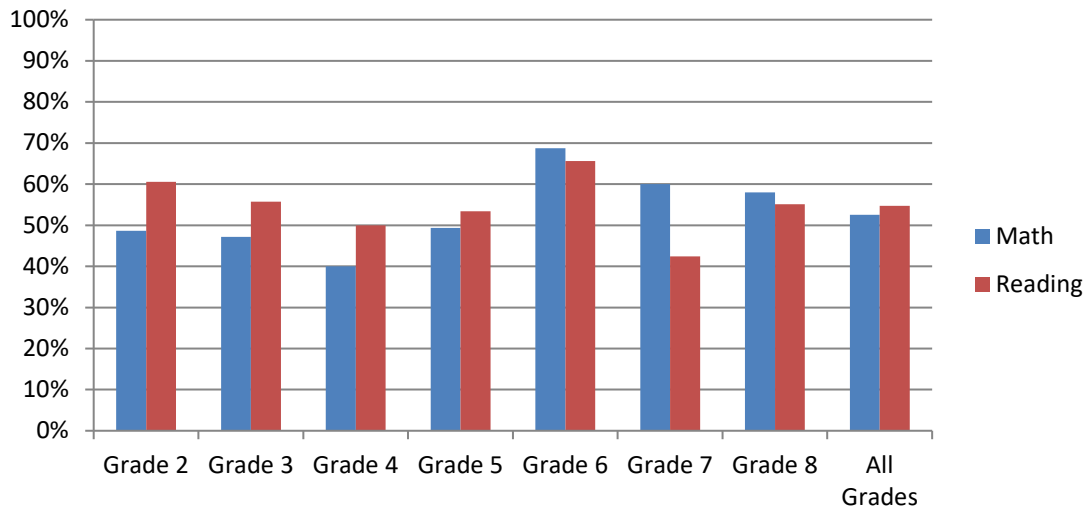

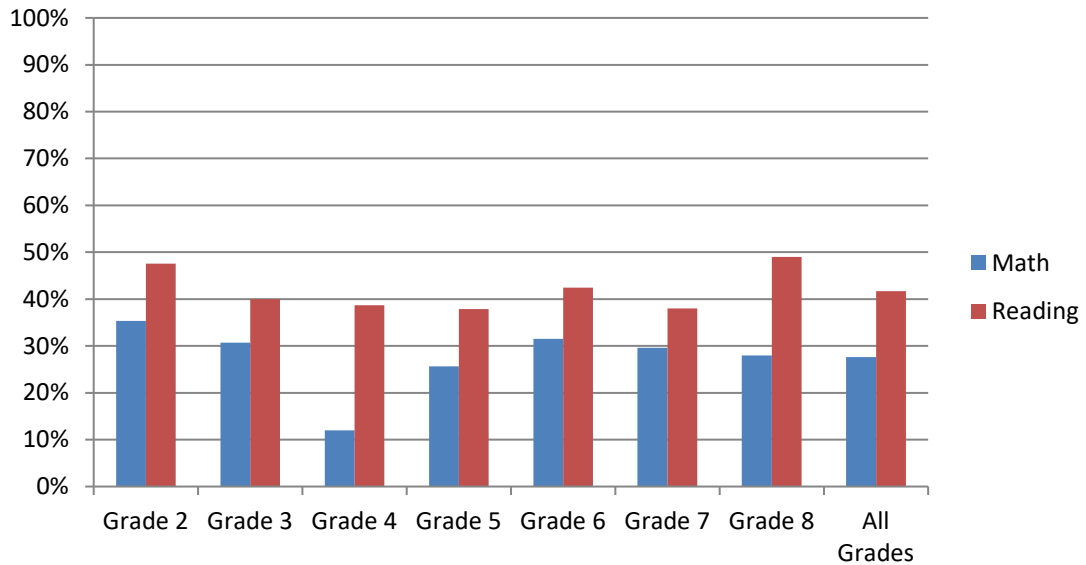

Detailed below is a graph depicting the percentage of students in our school meeting growth targets from fall 2016 to spring 2017.

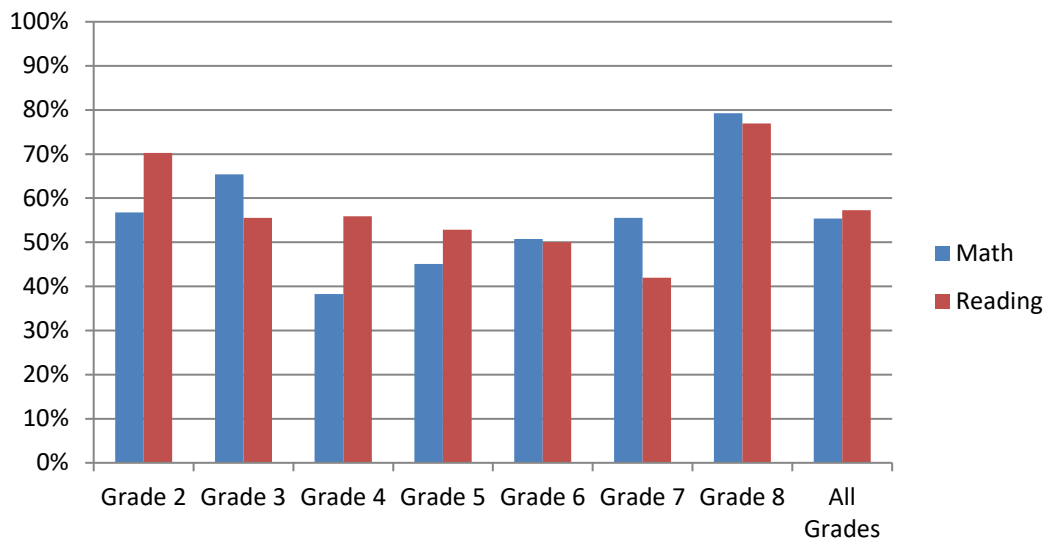


Detailed below are the percentages of students performing at or above the 50th percentile on the spring 2017 administration of the NWEA MAP assessment.

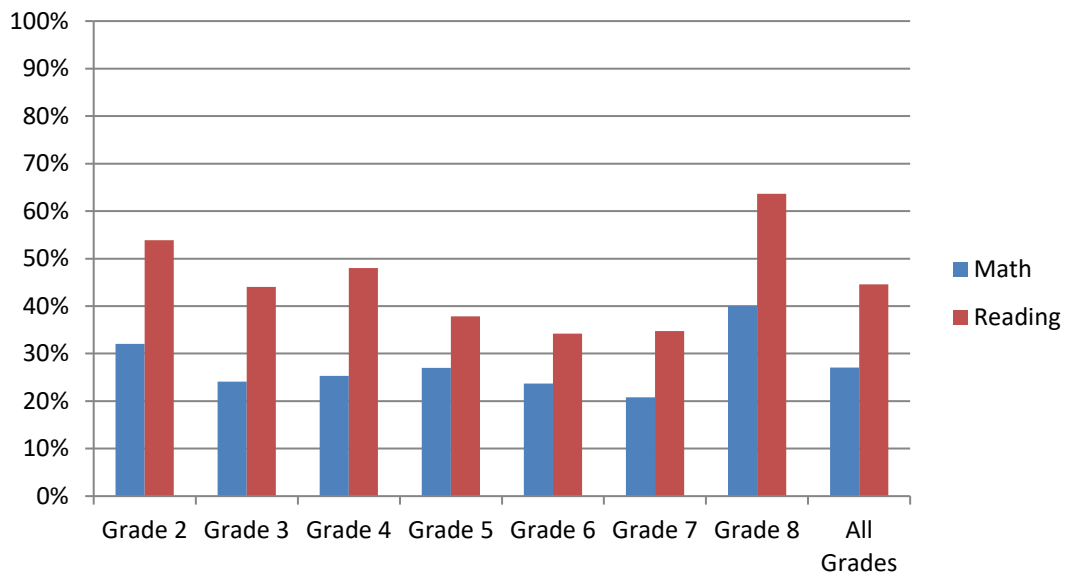

7. SCHOOL YEAR HIGHLIGHTS

- Reach outperformed Roseville and East Detroit on the MSTEP.
- In grades 2-8, Reach had higher NWEA growth results than previous years. The rate of growth as a school overall was higher than the NHA average in reading (133%), and on target in math (100%).
- In grades K-1, Reach's NWEA growth results exceeded the NHA average of 100% in both reading and math. Reading had a rate of growth of 140%, and a rate of growth of 119% in math. Both numbers are the highest they have been in 5 years. Kindergarten specifically had 86% of students proficient in math and 69% proficient in reading at the end of the year.

We are looking forward to another rewarding and successful school year in 2018-19!
