SMART Goal:

By spring 2023, Bennett will create and implement a positive proactive system to improving attendance school wide creating a better system that will improve the communication between school and families to improve overall attendance rates. Currently, 54% of students have 8 or more absences, Bennett Venture plans to decrease the percentage of chronically absent students by 5% year over year for the next 3 years.

Root Cause(s):

Using a proactive approach to attendance versus a reactive approach would help capture students and their barriers to attending school can help be removed before they becoming chronically absent.

Student Measure:

A benchmark for student success would for us to see a decrease in tardiness and daily absences.

Adult Implementation Measure:

A benchmark for adults/staff would be to see accurate data being uploaded in the attendance system. We will review data at least monthly and create and implement with fidelity an internal attendance process.

\$ 1.1) School Climate and Supports

G 2) Behavioral supports

SMART Goal:

Currently, staff lack the knowledge and support on how to best create a safe environment for appropriately preventing and managing student behavior. In 2020-2021 Bennett reported 437 Level 2, 83 Level 3 and 22 Level 5 related behavior incidents, we would like to see a decrease by 25% in Level 2 and 3 behavior incidents and a decrease in Level 5 behavior incidents by 50% by 2023.

Root Cause(s)

An increase focus on training staff on how to appropriately prevent and manage student behavior will decrease academic time loss due to disciplinary action.

Student Measure:

A benchmark for student success would for us to see a decrease in negative behavior documentations and an increase in positive behavior.

Adult Implementation Measure:

Staff will review data in one-on-ones, team, and staff meetings. This data will be reviewed to ensure that staff are tracking both positive and negative behaviors so show the most accurate behavior trends. Leadership will also review feedback and impact that professional development training will have on overall behavior.

Mentors will meet with mentees to share best practices and offer encouragement and support at least monthly but recommended weekly or bi-weekly according to the needs of the mentee. Mentor will attend and participate in mentor training sessions per state requirements and participate in professional development as needed to develop mentoring skills.

G 3) Literacy

SMART Goal:

Over the last few years, Bennett Venture has changed leadership many times. This inconsistent leadership has shown a problem with scores on staff perception surveys. Scores have decreased by over 15 points in the following areas, feeling supported by their manager, confidence in leadership, and culture. Over the next 3 years, school leadership would like to increase these scores by 10% in each category. It is Bennett Venture's hope that if leadership can create a positive culture for staff, consistent message and a clear voice with instruction literacy scores can also increase year after year.

Root Cause(s):

Leadership and staff turnover has caused a lack of clear direction and consistency. This lack of direction and consistency has not allowed for leadership to coach teachers on how to effectively use their both core and supplemental resources to help increase academic proficiency among students.

Student Measure:

A benchmark for student success would for us to see an increase in interim scores.

Adult Implementation Measure:

Observations (teachers and the classroom framework weekly, weekly o3, weekly grade level meetings, PD weekly, and TBTs once a month to ensure that there is a consistent message is being communicated throughout all grade levels.

Admin and teaching staff who assist in the planning and implementation of expanded learning time programs will be compensated for time spent on responsibilities outside of what is included in their job descriptions.
