For the 2016-17 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

The two biggest challenges we face are bringing our students up to proficiency and college readiness in all core subject areas and securing families at River City to improve our enrollment. Overall proficiency went up in each subject area but our proficiency is still very low. 16-17 M-STEP proficiency scores were Reading 21%, Math 10%, Science 4%, Social Studies 6%

### **Achievement Action Steps:**

- Continue to analyze our data to better meet the needs of our students to close the achievement gap
- Vertical planning and Gap Analysis in Science and Social Studies so that all grades, K-8, are teaching the standards necessary for students to be prepared for the next grade level
- Professional Development around strengthening core instruction, including engagement strategies, differentiation, and rigor
- More training/PD on data analysis and how to pinpoint and address student instructional needs
- Revisit the workshop model expectations for classroom teachers when interventionists pull groups.



### **Enrollment Action Steps:**

- Onboarded a new Admissions Representative
- Personal phone calls from the principal whenever a student/family withdraws
- Personal phone calls from Deans when parents are undecided about re-enrollment
- More marketing events to highlight the growth and successes we have made

River City Scholars Charter Academy is a state-funded, public school academy. Therefore, there is no cost to attend the Academy. The school is open to any child wishing to attend. Students must be age-appropriate for their respective grade, and they must reside in the state of Michigan.

By law, the school cannot restrict enrollment based on selection criteria. The school can, however, limit the total number of students who may attend the school. If the number of applications exceeds the number of offered seats, a random selection process will determine who attends the school.

The school's Open Enrollment period begins on the first day of the current school year and ends at 5 p.m. on the last day of business in February of the current school year. During this Open Enrollment period, all applications receive equal consideration regardless of the date submitted. At the close of Open Enrollment, all applications received during the Open Enrollment period will be counted. If applications received are fewer than offered seats in each and every grade level, all applicants will be accepted and will receive a notice of acceptance into their respective grades. If the number of applications received exceeds the number of offered seats in any grade level, a random selection process will take place for all affected grade levels. Names are randomly selected until all offered seats have been filled. Any remaining names are selected to establish waiting list priority. ### 3. A BRIEF DESCRIPTION OF EACH SPECIALIZED SCHOOL

#### 2016-2017

River City Scholars Charter Academy was founded in 2012, and 2012-13 was its inaugural school year. The school currently serves approximately 550 students in Kindergarten through eighth grade. The school is located in an urban setting on the southeast side of Grand Rapids within the Grand Rapids Public School district area.

2016-2017 saw the lowest teacher turnover in 3 years moving from 27.33% to 3.99% turnover. In 16-17, River City served a student population of 509 with 83.8% Black or African American, 9.8% Hispanic, 4.6% White, .2% American Indian or Alaskan Native, 1.2% Asian, and .6% other. The socio-economic status was 79% free lunch, 7% reduced lunch, and 13% not eligible. The EL population was 11% and 10% of students had IEPs. 2016-2017 state proficiency was 21% in ELA, 10% in Math, 4% in Science and 6% in Social Studies.


#### 2015-2016

River City Scholars Charter Academy was founded in 2012, and 2012-13 was its inaugural school year. The school currently serves approximately 550 students in Kindergarten through eighth grade. The school is located in an urban setting on the southeast side of Grand Rapids within the Grand Rapids Public School district area.

40.5% of students enrolled in the 2013-2014 school year did not return for the 2014-15 school year. In 14-15, River City served a student population of 560 with 75% Black or African American, 10% Hispanic, 7% White, 7% Multi-racial, and 1% American Indian or Alaskan Native. The socio-economic status was 88% free lunch, 6% reduced lunch, and 6% not eligible. The EL population was 10% and 10% of students had IEPs.

2014-2015 saw very high teacher turnover, with 15 teachers not returning from the prior year. 100% of staff were highly qualified. The number of suspensions, both in and out of school, decreased significantly in 14-15 from the prior year, with 129 less in school and 175 less out of school suspensions. State Test Proficiency in 14-15 was 18% proficient in ELA, 2% proficient in science, 5% proficient in social studies and 14% proficient in math. 14-15 Writing and Reading scores were not available, but 13-14 saw 36% proficient in reading and 23% proficient in writing.

2015-2016 state proficiency was 17% in ELA, 10% in Math, 4% in Science, and 5% in Social Studies. NWEA fall to spring rates of growth were 120% in Reading and 114% in Math. There were a total of 432 suspensions in 15-16.

Our goal of preparing students for college success has required us to take a unique view in terms of our curriculum. Our goal is to graduate students who have not only had the opportunity to experience academic excellence, but have acquired the knowledge and skills necessary to be successful in high school and college. What makes our curriculum particularly unique is that it has been developed to support state standards with a college-bound approach.

Our curriculum was developed based on the analysis of standards and assessment experts across the nation, including groups such as National Assessment of Educational Progress (NAEP), ACT®, Achieve, Inc., the Thomas B. Fordham Institute, the National Council of Teachers of English, The National Mathematics Advisory Panel, the American Association for the Advancement of Science, and the National Council for Social Studies. This analysis, conducted by National Heritage Academies, comprehensively researched what students need to know to be successfully prepared for rigorous high school and college educational programming. NHA then worked backward to develop a curriculum that defines the expertise needed by students in kindergarten through eighth grade to enter high school on the path to college readiness. Since college readiness goes beyond academic preparedness, the curriculum not only includes learning goals in core academic and co-curricular areas, but also includes an integrated character development component.

The curriculum's objectives are aligned to those identified by the Michigan Academic Standards: both the Common Core State Standards (CCSS) and the Grade Level Content Expectations (GLCE). Moreover, all students are expected to reach the CCSS and GLCE goals. However, modifications/accommodations are sometimes necessary to ensure learning for all students. The only variance in our curriculum when compared to the Michigan Academic Standards is the addition of a Moral Focus component. This Moral Focus program is explicit and integrated with the school's core curriculum. A different virtue is featured each month of the school year. 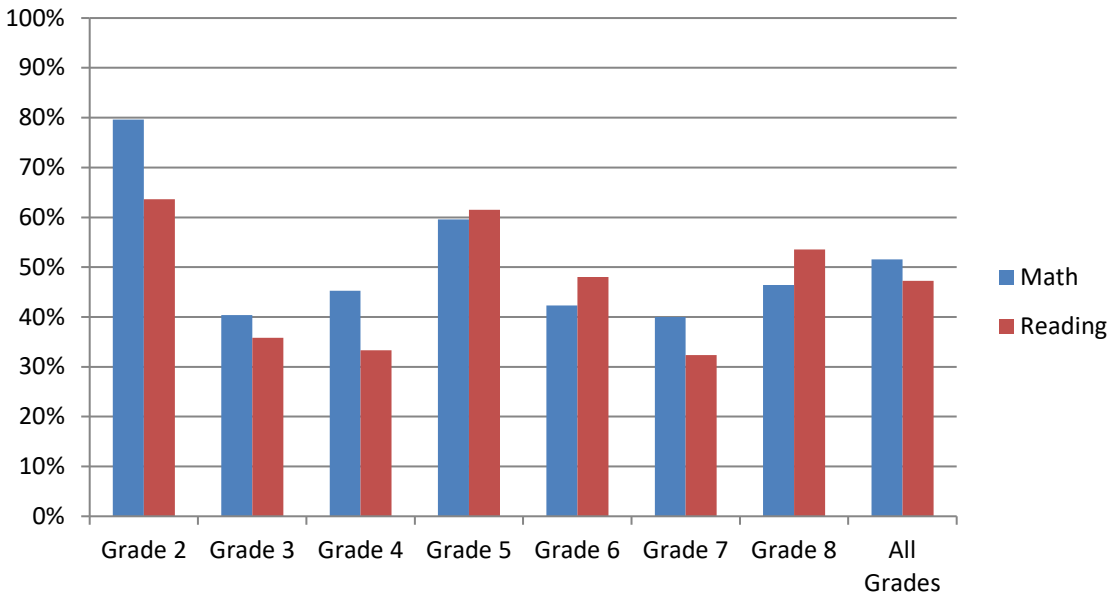

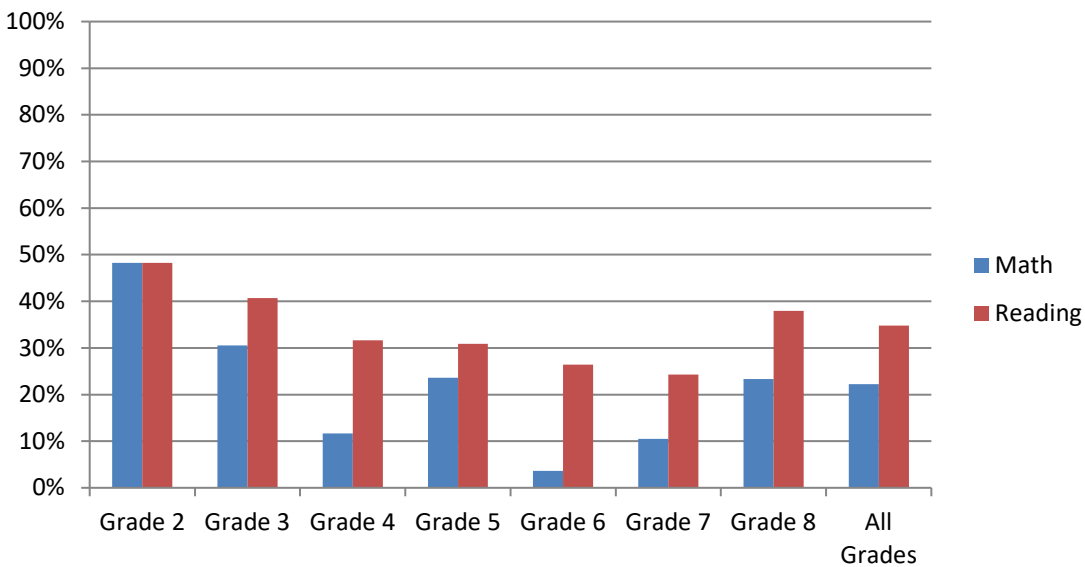

Detailed below is a graph depicting the percentage of students in our school meeting growth targets from fall 2016 to spring 2017.

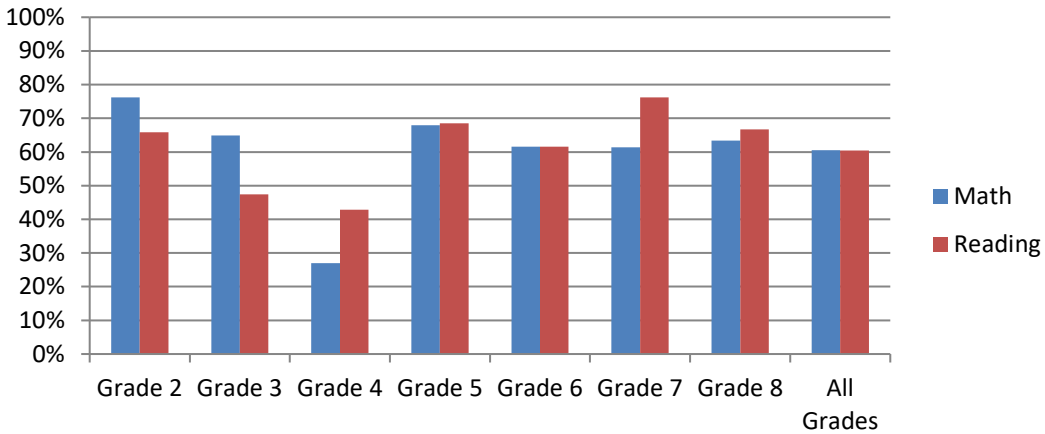


Detailed below are the percentages of students performing at or above the 50th percentile on the spring 2017 administration of the NWEA MAP assessment.

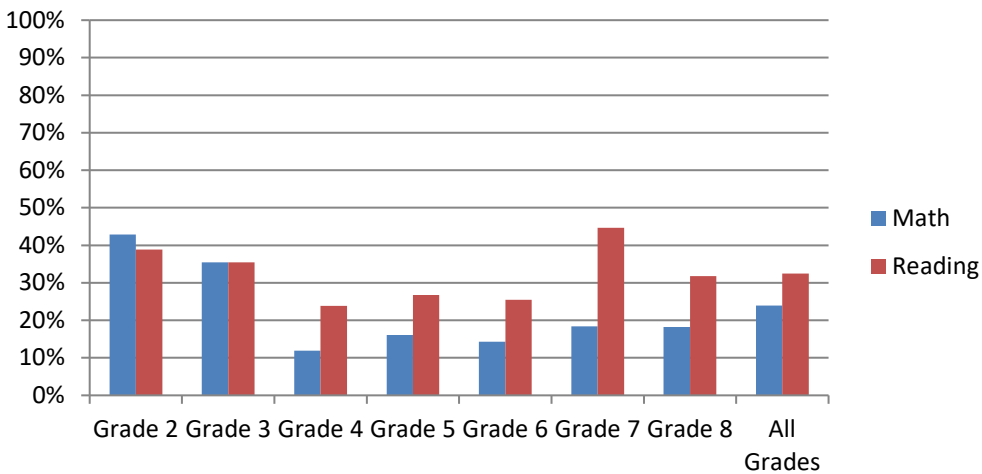

7. SCHOOL YEAR HIGHLIGHTS

- 16-17 saw very low teacher turnover with only 3.99% allowing for consistency in relationship building, River City routines and procedures and instructional growth.
- River City's CAP score, which takes into account student demographics, was 100.4 with a 51.13 percentile ranking showing that we have made progress over the last 3 years.
- Our intervention program is structured so that all students receive small group reading and math support twice a day for 40 minutes using research-based curriculum and strategies.

- 
- 16-17 Staff Glint Survey results and Parent Satisfaction Survey results both showed an overall increase in satisfaction across the board.
  - Student behavior incidents and suspensions have decreased significantly with an average of 17.5 incidents per student in 15-16 to 8.2 in 16-17.

We are looking forward to another rewarding and successful school year in 2018-19!
