Subject: Fiscal year 2026 Section 31a Annual Transparency Report

Dear Parent/Guardian,

The primary focus of Section 31a of the Michigan State School Aid Act provides funding to ensure that pre-Kindergarten-12th grade *at-risk eligible students* demonstrate proficiency in:


- 3rd grade English Language Arts
- 8th grade Mathematics
- College and Career Readiness by High School Graduation
- Regular Student Attendance

An *at-risk student* is any K-12 student that meets one or more of the identification criteria outlined in the Section 31a legislation.

In compliance with [MCL-Section 388.1631a \(17\) of the State School Aid Act](#), beginning in the 2025-2026 school year and every year thereafter, each district who receives Section 31a funds must provide a notification to parents/guardians that includes the amount of funding received under the grant, how the district distributed those funds, and what evidence-based interventions were implemented with those grant dollars.

During the 2025-2026 school year, Ridge Park Charter Academy received Section 31a funds from the state of Michigan. This letter serves as notification of the transparency reporting requirements under the law.

 - Ridge Park Charter Academy is a single-building district, and therefore all Section 31a funds received are allocated to Ridge Park Charter Academy.
 - In what ways has the district collected feedback from parents/caregivers on the supports and interventions provided with Section 31a funds this year?
 - Parents, staff, school board, and community members' feedback, on state and federal-funded programs, is solicited via participation in surveys during the following annual stakeholder meetings:
 1. Fall Parent Meeting for Federal and State Programs
 2. Spring Continuous School Improvement Stakeholder meetings
