# Atlanta Heights Charter School Parent and Family Engagement Plan School Year 2024-2025

In support of strengthening student academic achievement, Atlanta Heights Charter School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(a)(2) of the Every Student Succeeds Act (ESSA). Atlanta Heights Charter School agrees to implement the following requirements as outlined by Section 1116:

Atlanta Heights Charter School implements the required components of ESSA Section 1116 Parent and Family Engagement involvement and opportunities for stakeholder input through the following:

- Annual Title I Parent Meeting held each year before November 1.
- Multiple Parent Learning Events designed to educate parents on how to help their child(ren) succeed academically are held each year
- Multiple Parent and Family Engagement activities are held throughout the school year
- Parent Teacher Conferences are held in the Fall and Spring
- Annual Parent and Family Engagement Program Evaluation and Input Meeting
- Parent School Improvement Planning and stakeholder input meeting

- Provide information and Communication, to the extent practical, in a language parents understand

#### TECHNICAL ASSISTANCE

National Heritage Academies (NHA) will provide the following coordination, technical assistance, and other support necessary to assist and build capacity of Atlanta Heights Charter School in planning and implementing effective parent and family engagement activities to improve student academic achievement and school performance, which may include meaningful consultation with employers, business leaders, and philanthropic organizations, or individuals with expertise in effectively engaging parents and family members in education:

Annually, the Service Center provides to the school, a School Improvement Planning Workbook for the School to conduct a comprehensive needs assessment and design supplemental programs for the following school year utilizing applicable federal and state funding. The SIP Workbook includes data sets as well as templates designed to illicit stakeholder input for applicable federal and state funding and other supplemental grant programs

Each Spring NHA staff meets with School staff to solidify applicable federal and state supplemental grant program design plans for the upcoming school year based on the comprehensive needs' assessment.

By June 30, NHA staff submits the School Improvement Plan (CLIP)

By October 1, NHA staff submits the Consolidated Application and/or other supplemental grant applications to the State Education Agency

Annually, the Service Center School Finance team publishes a Grants Compliance Requirements and Guidance with timeline and updates which outlines all of the School's compliance responsibilities and houses forms, templates, and legislation for their use, as a means of providing guidance and technical assistance related to ESSA, Title I, Title I SIP, Title IIA, and Title IV, CARES/CRSSA/ARP, Schoolwide/School Improvement revision processes and federal and state program requirements, etc.

The Service Center School Finance team utilizes an online platform for submission and retention of grant-funded compliance documentation. Weekly, monthly, and past-due reminders for compliance tasks are sent to the school. These email reminders include due dates for the corresponding compliance requirements. This online platform is available for schools to upload, view, and retrieve their supporting documentation.

The School and NHA communicate on an ongoing basis regarding findings determined throughout the monitoring process and implementation period including but not limited to

The NHA Service Center staff as well as the SpEd accountant and SpEd supervisor work with the School to provide guidance and technical assistance via phone, email, virtual meetings and/or formal and informal in-person visits to answer questions, provide clarification and collect documentation to ensure compliance requirements are met.

NHA provides the School access to on demand data reports via the myNHA website to assist the School with their efforts to evaluate supplemental programs. The School reviews a variety of data to evaluate applicable federal and state programs, including but not limited to student achievement data, demographic data, program and process data, and perceptions data.

The School Quality team at NHA works with the School to discuss program data, including the comprehensive needs assessment, and to analyze the effectiveness of supplemental programs prior to finalizing plans for the following school year.

## JOINTLY DEVELOPED

Annually and prior to November 1st, Atlanta Heights Charter School will hold a Title I Parent Meeting. As a Schoolwide School, all parents will be invited and encouraged to attend.

The results of the surveys are analyzed by a committee of various stakeholders including but not limited to school leadership, staff and parents. If needed the Parent and Family Engagement Policy/Plan will be revised by the committee and published for the upcoming school year.

## **RESERVATION OF FUNDS**

Atlanta Heights Charter Academy will involve the parents and family members of children served in Title I, Part A program in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent.

## **BUILDING CAPACITY OF PARENTS**

Atlanta Heights Charter School will build parents' capacity for strong family engagement by providing materials and training on such topics as literacy training and using technology (including education about the harms of copyright piracy) to help parents work with their children to improve their children's academic achievement. Assistance will also be provided to parents in understanding the following topics:

- The challenging State academic standards
- The State and local academic assessments including alternate assessments

At least two times each year the school will host parent teacher conferences to give parents the opportunity to discuss and receive information regarding their child's academic progress

Parents will be invited to various Parent Learning Event opportunities/workshops to assist them in understanding state and academic standards, school curriculum and state assessments along with how to monitor their child's progress and resources to help them at home.

These Parent Learning Events will be held at days, time, locations and formats that are convenient for parents to attend. In addition, if needed interpreters and or materials will be provided in a language that parents understand.

The Parent Room has educational resources and materials available for parents to checkout and use to aid in improving their student's academic achievement at home.

Parent Learning Events will be communicated to parents in various ways including but not limited to Newsletters, U.S. Mail, Email, Texts, School Messenger (phone announcements), flyers, the school website and social media.
