- Summer learning programs and tutoring programs were the items that most stakeholders indicated as being the highest priorities for the 2022-2023 school year.
- Materials and resources were found to be the second highest priority among stakeholders, and the third highest priority was retaining and attracting highly qualified staff.
- · Social emotional learning programs were prioritized higher from teachers and staff than they were from parent populations.
- · Attracting additional school personnel was prioritized higher than items relating to technology or PPE.
- · PPE and digital tools were not highly prioritized.
 - 2. How will these trends be addressed using COVID funding?
- · Invest more into summer school tutoring programs.
- · Increase the hourly rate of summer school staff.
- · Increase number or resources and programs that address social emotional learning
- Increase number of after-school tutors
- Invest in outside tutoring programs that will provide tutoring for a longer period throughout the year.
